MINISTERIAL DECREE

Introduction of a mandated pre-shipment Verification of Conformance (VoC) for products imported into Somaliland.

The Ministry of Trade and Tourism of the Republic of Somaliland hereby announces the introduction of a mandatory pre-shipment verification of conformity program (VoC) for goods imported into Somaliland.

The VoC program aims to provide numerous advantages for the end consumers and citizens of Somaliland by reducing sub-quality, unsafe, counterfeited and non-compliant goods. The control of import against harmonized standards will in addition create a fair marketplace for the traders and local manufactures.

The conformity assessment process and issuance of Certificates of Conformity (CoC) should be performed and delivered in the country of origin or supply before shipment to Somaliland. The CoC will be required at the Customs clearance and Ministry of Trade and Tourism in Somaliland for every consignment and products covered by the VOC program.

The Ministry of Trade and Tourism has appointed Cotecna Inspection (sole and exclusive); an international leading provider of inspection, testing and certification to deliver the VoC services, throughout the world.

To assess the conformity of a shipment, the VoC process will follow one of the four levels of compliance, named "routes". The choice of the route depends on the profile of the exporter and the nature of the goods. These are:

- Route A for exporters with infrequent shipments or sensitive goods
- Route B for exporters with regular shipments (registered products)
- Route C for manufacturers with regular and high-volume shipments (licensed products)

One month following the date of issuance of this letter 15th March, 2022, the pre-shipment verification of conformity program (VoC) for goods imported into Somaliland will be mandatory as of 16th April, 2022.

As a consequence, large traders are informed to submit their Certificate of Conformity by this date before shipment.

Somaliland Verification of Conformity Programme

The Somaliland Ministry of Trade and Tourism regulates the mandatory Pre-Shipment Verification of Conformity programme for products exported to the Republic of Somaliland.

The Ministry of Trade and Tourism appointed Cotecna Inspection S.A (Cotecna) to verify the conformity of products exported to Somaliland. Cotecna is mandated to inspect, test regulated products, and issue Certificates of Conformity on behalf of the Somaliland Ministry of Trade and Tourism.

All imported product consignments must be accompanied by Certificates of Conformity to be processed for Customs clearance and business use.

Benefits of Certification

The programme aims to ensure that imported products comply with the regulatory safety standards set by the Somaliland government. In addition, the programme will protect the health, safety, and environment by reducing the risk of unsafe and substandard products entering Somaliland. The programme will also promote fair competition for local manufacturers and traders.

Complying with the programme will enable importers to avoid unnecessary Customs delays and the risk of having their products returned to the exporting country.

Regulated Products

The majority of the products imported into Somaliland are regulated and will require a Certificate of Conformity.

The regulated products are found under the following HS Chapters: 02-05, 07-11, partially 12, 13-27, 30-35, 38- 40, 44-66, 68-76, 78-87, 90-92, 94-96

Certification of Conformity Process

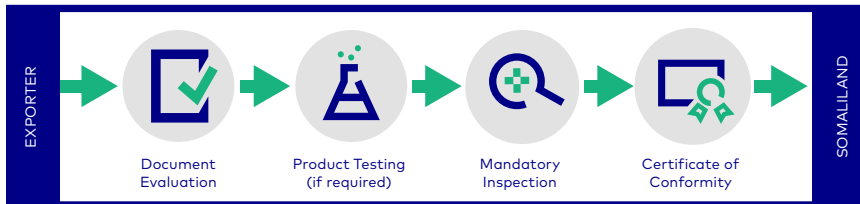
Exporters must take the following steps to obtain COCs:

1. Fill out and submit the Cotecna [Request for Certification](#) (RFC) form.
2. Cotecna will then assess your application and the accompanying documents to determine the certification scope. Certification scope can include product inspection, testing, shipment loading and sealing as required.
3. Report assessment to verify conformity
4. Upon satisfactory results, issue Certificate of Conformity (COC).

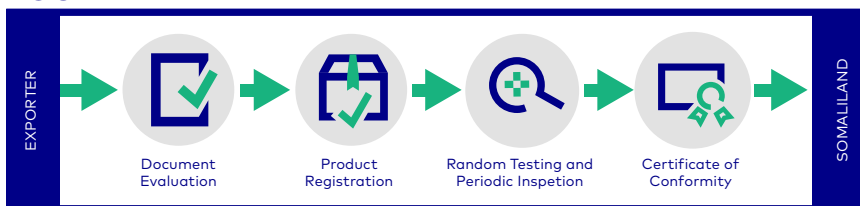
Certification of Conformity

Somaliland uses three "routes" to determine conformity compliance. The choice of the route depends on the profile of the exporter and nature of goods.

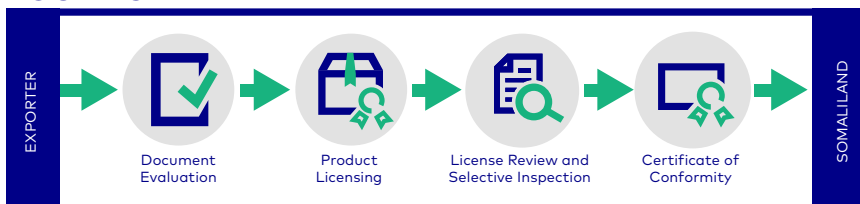

SOMALILAND VERIFICATION OF CONFORMITY (VOC) PROGRAMME

The Republic of Somaliland's Ministry of Trade and Tourism regulates the mandatory **Pre-shipment Verification of Conformity** programme for products exported to Somaliland.

The VOC programme aims to protect Somaliland consumers and the environment by reducing sub-standard, unsafe and counterfeit products imported into Somaliland. The programme will also promote fair competition for local manufacturers and traders.

To ensure harmonized compliance to the set safety standards and regulations, The Somaliland Ministry of Trade and Tourism appointed Cotecna Inspection S.A (Cotecna) to issue Certificates of Conformity (COC) on its behalf.

Every consignment of regulated products exported to Somaliland must be accompanied by a Certificate of Conformity issued by Cotecna.

This guide covers the requirements of obtaining the mandatory Certificate of Conformity needed for customs clearance.

REGULATED PRODUCTS

The majority of products imported into Somaliland are regulated and will require a Certificate of Conformity.

The regulated products are found under the following **HS Chapters**: 02-05, 07-11, partially 12, 13-27, 30-35, 38- 40, 44-66, 68-76, 78-87, 90-92, 94-96

CERTIFICATE OF CONFORMITY PROCESS

The conformity assessment process and issuance of Certificates of Conformity (COC) is performed and delivered in the country of origin or supply, before shipment to Somaliland. The COC will be required for the **Customs Clearance** and **Business Process** in Somaliland for **every consignment** of products regulated under the VOC programme.

Note: To start the conformity process, fill out and submit the Cotecna **Request for Certification (RFC)** form.

The pre-shipment certification process includes one or a combination of the following kinds of verification to ensure the product is compliant with Somaliland, Regional or International standards:



1. Documentation verification

The exporter/applicant must provide Cotecna with the following documents for verification:

- i) A filled out **Cotecna Request for Certification form**
- ii) Commercial Invoice
- iii) Packing List
- iv) Valid conformity documents (such as laboratory test reports issued by an ISO 17025 accredited laboratory, technical data, analysis certificates, Quality Management System certificate, etc) and any other relevant documentation.



2. Laboratory testing in the exporting country

If the product test report is not available or is missing essential test criteria, Cotecna will take samples from the shipment and perform the necessary tests in an ISO 17025 accredited laboratory.



3. Physical inspection in exporting country

Cotecna will physically inspect the goods and ensure that essential markings comply with Somaliland standards, take samples (see above) and seal the container if required.



4. Certificate of Conformity

Cotecna will issue a Certificate of Conformity (COC) only if the product meets the Somaliland requirements, following a successful completion of the evaluation, inspection and testing. **Without a valid COC, Somaliland Customs will not clear goods for importation.**



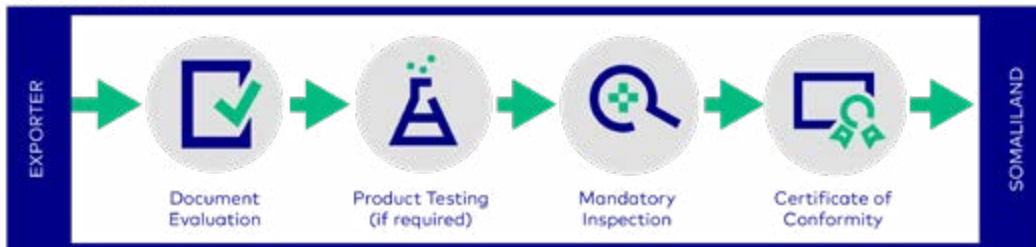

CERTIFICATE OF CONFORMITY ROUTES

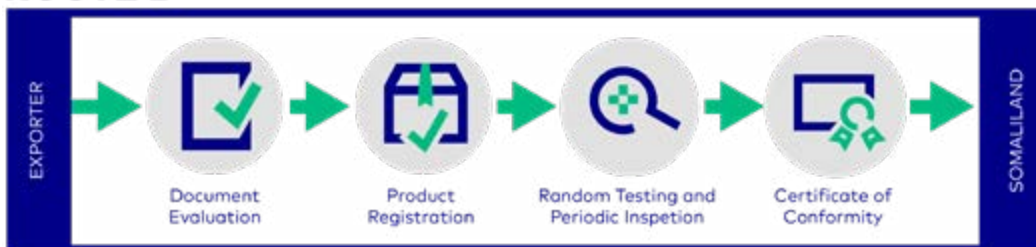

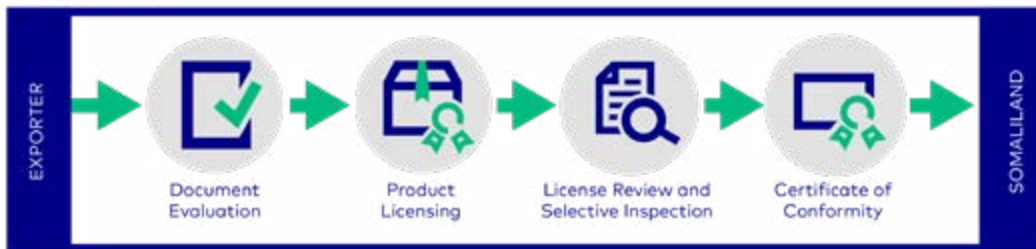
