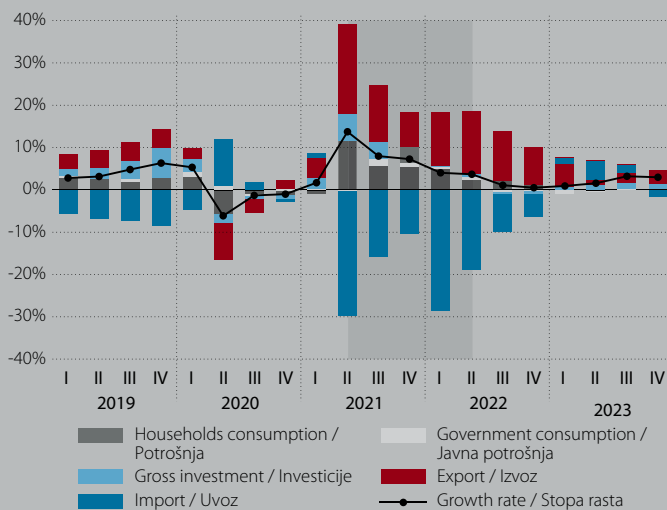
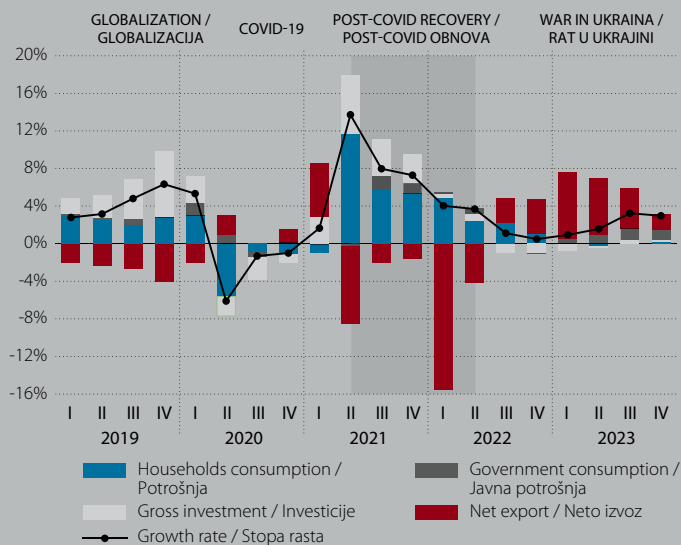
## Business cycle in Serbia / Privredni ciklus u Srbiji

Score card tracking results in implementation of recommendations from White Book 2022.

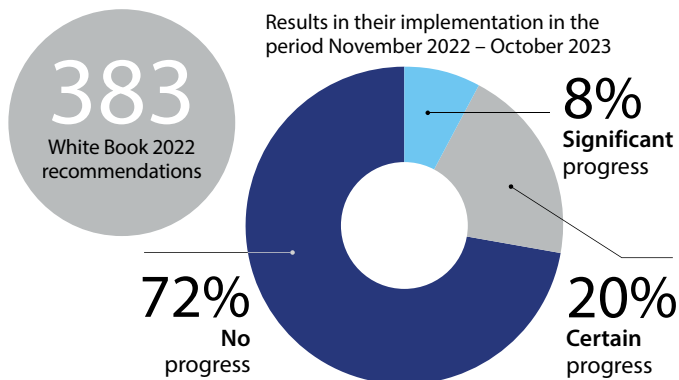

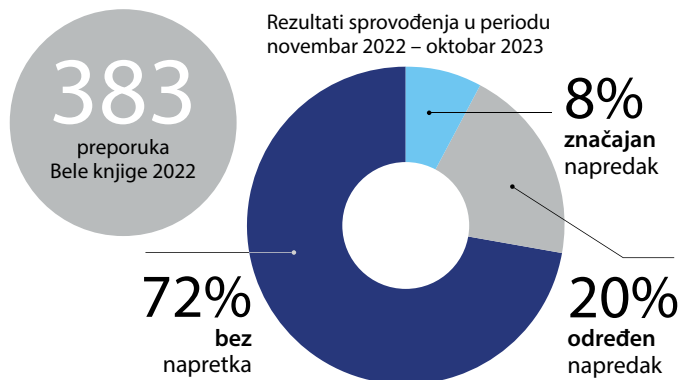

### Positive developments

in the period Nov 2022 – Oct 2023

Efficient harmonization with EU regulations and more flexible rules were accepted on the origin of goods between the Republic of Serbia, CEFTA countries and PAN-EU members.

The E-Invoicing System (“SEF”) has been introduced as an information technology solution for sending, receiving, recording, processing and storing e-Invoices, followed by periodical technical improvements and the introduction of a unified Rulebook.

### Main recommendations for the future

Organize timely public consultations around all new regulations and regular dialogue with the business community.

Resolving the most pressing tax issues like the changes to the property tax law, fair value of property for corporate income tax purposes, parafiscals, etc.

Key novelties and positive developments include work and residence of foreigners simplification process and adopting new Law on Safety and Health at Work.

### Main recommendations for the future

It is necessary to amend key laws and enact appropriate bylaws, which regulate the field of labor, such as the Labor Law and bylaws on the Law on Safety and Health at Work. The changes should include digitization of labor law documents, more flexible working conditions outside the employer’s premises, rationalization of salary structure and salary compensation, more flexible conditions and procedures for employment termination.

### Positive developments in the period Nov 2022 – Oct 2023

Implementation of eInvoices has contributed to a significant administrative relief and transparency of transactions.

The Serbian Government and the Office for IT and eGovernment continued to implement the digital agenda.

Consent ID - a simple and affordable digital identity for the widest range of citizens.

By integrating eid.gov.rs with the Agency for Business Registers (apr.rs), digital identity users are enabled to establish companies, submit all types of applications and records etc.

Digitalization of financial services continued, through a series of decisions that the regulator, the National Bank of Serbia, prescribed in the previous period.

### Main recommendations for the future

In order to improve the efficiency and security of business operations, it is necessary to enable the automated data exchange between the public and private sectors.

Reduce the cost of electronic archiving of company documentation through the amendments of regulations along the lines of excluding the largest part of business documentation as it is not relevant for culture, art, science and other categories of the Law on Archival Material and Archival Activities.

To enable the development and roll-out of the second generation video identification encompassing biometric safeguards within the client validation framework with the aim of further enhancing client security and promoting the development of digitalization in Serbia.

In the implementation of the Law on Electronic Communications, the Rules of Procedure on prepaid registration of mobile users should enable simple electronic registration of customers.

Amendments to the Law on Planning and Construction are expected to contribute to the further growth of the construction sector.

Conversion of construction land with a fee for certain categories of individuals has been abolished, and “green construction” and other elements of the green agenda have been defined.

The introduction of the “E-space” information system for spatial planning and construction is expected to streamline the processes of issuing construction permits and other necessary licenses.

Amendments to the Law on State Survey and Cadastre and Amendments to the Real Estate and Utility Cadastre Procedure have been adopted, which are expected to improve operations and the commencement of work on the introduction of an infrastructure registry.

### Main recommendations for the future

Issuance of construction permits within a consolidated procedure with the appropriate content that will enable property rights registration without additional time and cost for obtaining additional specific documentation, and their implementation ex officio.

Continue with intensive work to achieve uniform practice and clear application of the law for further acceleration of operations and predictability of cadastral procedures.

# FIC COMMITTEES

The Committees are the core bone of FIC and most credited for the White Book preparation. They are the platform where FIC members exchange ideas, share best practices, and jointly formulate proposals how to overcome existing regulatory obstacles. Currently, 9 committees operate within FIC:

## Anti-Illicit Trade & Food Committee

Aim of the Committee is to improve the regulatory framework related to the food and agriculture industries and intensify the fight against illicit trade through regulatory changes and better law enforcement.

## Financial Services Committee

This Committee is dedicated to improving the regulatory environment for financial services in Serbia to modernize the market and facilitate economic growth with focus on digitalization, capital market, prevention of money laundering, insurance and leasing.

## Human Resources Committee

Mission of the Committee is to work on proposals for removing obstacles faced by investors in HR area and labour regulations, to make suggestions on how to enhance the quality of the human resources in the country stretching its portfolio from managing to educational aspects of the HR policies.

## Infrastructure & Real Estate Committee

Committee's activities are aimed at improvement and modernization the framework for development of the infrastructure and real estate, energy, and transportation. This includes advocating for the implementation of the strategies, development and coming up with new proposals to modernize regulatory framework.

## Legal Committee

The Legal Committee focuses on the analysis of general legal framework in Serbia. Aim of this cross-sectoral Committee is to advocate for improvement of the overall legal framework by closely monitoring the work of Serbian authorities and generating proposals for its improvement.

## Pharma Industry Committee

Aim of this sectoral Committee is to promote the needed reforms of the health sector, health insurance model and advocate for the full harmonization of legislation with the EU and removing legislative obstacles.

## Taxation Committee

Taxation Committee, that gathers members from virtually all fields, contributes to upgrading tax system to align it with international practices and OECD guidelines and improve consistency in implementation and work of the Tax Administration.

## Telecommunications & Digital Economy Committee

Aim of this Committee is to advocate for the improvement of the investment climate in the sector of Telecommunications, for removing legislative and other barriers for further development of e-Commerce and digital services and to promote new business models.

## Tourism and Hospitality Committee

The main focus of the Tourism & Hospitality Committee is the need for improvement of the regulatory framework, as well as tourism governance, and advance a cross-cutting government approach, including innovative solutions and effective coordination of all objectives under a shared vision of improved destination competitiveness.
