The Chairman Ministry Procurement Committee (MPC) on behalf of Litro Gas Lanka Limited invites sealed bids from eligible and qualified bidders for the supply of 510,000 numbers of LPG Compact Valves for Domestic LPG Cylinders for Litro Gas Lanka Limited.

The bids should be submitted by reputed manufacturers who have at least ten years' experience in the field of Supplying LPG Compact Valves for LPG Cylinders to both local and foreign markets.

The Bidder shall furnish as part of its' bid, a Bid Security in the form of a Bank Guarantee from a commercial bank operating in Sri Lanka. The bid security shall be valid up to **16th October 2024**.

The value of the bid security should be **USD 24,000.00**.
